## Matching gifts

AK Steel organized the Foundation to be a good neighbor and be socially responsible in the communities in which we live and operate. To help the company meet these goals, the Foundation supports health, welfare, higher education, cultural, arts and civic organizations in our communities.

As a part of that commitment, and continuing the long tradition of supporting these groups, the Foundation has a Matching Gift Program. Under this program, the Foundation will match eligible individual gifts of cash or marketable securities according to the guidelines in this brochure and other rules as may be established by the Foundation. All matching gifts by the Foundation will be unrestricted to the recipient organizations. The Foundation will not direct its matching gifts to specific programs, events or other designations.

### Who is eligible?

Active full-time employees of AK Steel and its whollyowned subsidiaries, and Directors of AK Steel Holding Corporation are eligible.

Employees are eligible to participate on and after their hire date, so long as they remain on active status. Directors are eligible to participate on and after their election date. Retired employees, retired Directors and employees on status other than "active" are not eligible to participate.

Employees of joint ventures or partnerships, who are not employees of AK Steel or its wholly-owned subsidiaries, are not eligible.

The Foundation Matching Gift Program is not part of the AK Steel employee/director benefits program. Rather, it is offered as a public service by the Foundation, the charitable foundation established by AK Steel.

#### How the matching gift program works

Your gift must be a personal contribution, not a pledge, from your own resources. It must be paid in cash or in securities having a publicly quoted market value. You must certify the value of a security as of the date it is contributed.

### Minimums and maximums

The minimum gift that will be matched is \$25, and the maximum gift that will be matched is \$5,000 for any type of eligible charity. Any non-deductible portion of a gift will not be matched. There is an annual (January 1 to December 31) individual maximum of \$5,000. The Foundation will not match amounts that would exceed the annual total of \$5,000 for an employee or Director.

The Foundation, in its sole discretion, may suspend, change, revoke, or terminate this Program at any time. The interpretation, application and administration of the Program are determined by the Foundation, and its decision is final.
