EDUCATIONAL MATCHING GIFTS PROGRAM >

The Educational Matching Gifts Program is designed to encourage associates to make contributions to primary and secondary educational institutions, as well as colleges and universities. The Educational Matching Gifts Program is funded in cooperation with the Beckman Coulter Foundation, a separate, private foundation established in 2007 as an important part of Beckman Coulter's charitable giving efforts. This program is an example of the Beckman Coulter Foundation's overall support for education and recognizes the critical role all educational institutions have in developing our leaders of tomorrow.

ELIGIBLE GIFT DONORS >

All current associates of Beckman Coulter, Inc. and its wholly owned subsidiaries. Beckman Coulter Foundation directors are also eligible.

QUALIFYING EDUCATIONAL INSTITUTIONS >>

- A. Public and private elementary schools, middle schools and high schools that maintain a regular faculty, provide a full educational curriculum and are recognized by the appropriate governmental educational entity within each state or by the appropriate academic accrediting organization.
- B. Public and private junior colleges, colleges, universities and graduate schools, provided the school is recognized by the Council on Higher Education Accreditation (CHEA).
- C. Public and private special education schools for children with physical, mental or emotional disabilities, provided the school is listed in the Directory for Exceptional Children.

Educational institutions must be recognized by the United States Department of the Treasury as tax-exempt organizations under Section 501(c)(3) of the Internal Revenue Code and will not be private foundations as defined under Tax Reform Act of 1969. Additionally, all educational institutions must meet the IRS definition (Section 170(b)(1)(A)(ii).

MATCHING GIFT LIMITATIONS >

The Beckman Coulter Foundation will match individual associate gifts up to \$10,000 (U.S.) annually per contributing associate. However, if the total amount of associate gifts exceeds the funds allocated for this program, matching gifts may be apportioned in a manner the Beckman Coulter Foundation considers equitable. Associate gifts will be actual contributions made, not pledged. Associate gifts may be in the form of:

A. Check

B. Credit

C. Securities having quoted market value. Securities will be valued at the closing price listed in the Wall Street Journal at the end of the previous trading day from the original date of gift receipt. Matching gifts from the Beckman Coulter Foundation will be unrestricted.

Applications must be returned by educational institutions no later than December 1 of the current calendar year. Only applications received during the current calendar year are eligible for a match.

GIFT USAGE 🗲

Gifts are to be used exclusively for academic and educational purposes only. Gifts made toward capital campaigns or building projects are outside of the program's guidelines.

GIFTS NOT QUALIFYING >

Gifts made to associations, preschools, and PTAs or PTOs, as well as gifts made to educational institutions in return for benefits or service (e.g., tuition payments, membership fees to alumni associations, club dues and gifts, subscription fees for publications, etc.) are outside of the program's guidelines. Cultural schools that do not offer a full educational curriculum and professional non-profit educational organizations do not qualify for a match.

PROGRAM ADMINISTRATION >

Associates must complete **PART A** of this application with each new contribution and send it with their gift to the educational institution. Gifts may not be combined on the same application. A representative of the educational institution will complete **PART B** of this application and return it to the Beckman Coulter Foundation. The application will be reviewed by the Beckman Coulter Foundation, and the associate and educational institution will be notified as to whether the gift will be matched. The Beckman Coulter Foundation reserves the right to verify eligibility and determine if a matching gift is appropriate.
