Increase your donations

to accredited schools, arts organizations, historical societies, museums or public TV and radio by participating in the Deluxe Corporation Matching Gift Plan.

Who's eligible to participate?

• Full-time and part-time employees

Deluxe only matches gifts made directly to qualified organizations by eligible donors. Gifts made through a private foundation or trusts do not qualify for matching.

Which organizations qualify for matching?

- Accredited schools (colleges, universities, junior colleges, vocational technical institutes, and elementary and secondary schools that are recognized by national accrediting agencies or associations)
- Professional arts organizations
- Historical societies and museums
- Public (educational) TV and radio

Other requirements:

- United States organizations must have appropriate charitable status with the IRS
- Canadian registered charities must provide an accurate ID number and tax exempt status as issued by the Canada Revenue Agency and Charities Directorate

IMPORTANT: The Deluxe Corporation Matching Gift Plan office will not honor matching gifts to organizations associated with controversial activities or primarily concerned with religious or social service activities.

"Gifts" defined

Eligible

Gifts must be personal contributions made—not merely pledged—in cash or securities.

Contributions of securities (stocks and bonds) must include quoted market value on the date of transfer.

If you pay monthly or quarterly installments of your total contribution, please process *one* application form with your total annual contributions at year-end. In addition, Deluxe only honors matching gifts that are reported within *four months* of a donor's entire contribution or *four months* following the final year-end payment.

Ineligible

Gifts cannot be in the form of bequests, dues, subscription fees, insurance premiums, tuition, group collections submitted by an individual, or other such payments. Even though such payments ultimately provide financial benefit to an organization, they are not eligible for matching.

Amounts matched

Deluxe double matches qualifying gifts ranging from \$10 to \$2,500 of eligible donors. The \$500 double match benefit is applied to a donor's first matching gift form(s) received in the Deluxe Corporation Foundation office each year. Once the \$500 benefit has been reached, the remaining dollars will be matched on a one-for-one basis. Donors can contact the Deluxe Corporation Foundation office to discuss other options.

Deluxe appointed staff interpret, apply, and administer the Matching Gift Plan. The staff's decisions are *final*.

If total contributions for the year exceed the total amount appropriated for the plan, Deluxe reserves the right to prorate gifts according to available funds. In addition, the office reserves the right to revoke, suspend, or terminate the program at any time and has no obligation to match contributions made after that time.

How to participate

- Complete Part 1 of the application form on the back of this brochure
- Forward your contribution with this application form to the eligible organization
- The organization completes Part 2 and sends the completed application form to the Deluxe Corporation Foundation office
- After receiving the completed application form the Deluxe Corporation Foundation office sends a matching gift to the organization

The Deluxe Corporation Foundation office will acknowledge the gifts that Deluxe matches on your behalf after each quarter that you participate. Because some nonprofit organizations process donations more slowly that others, it may take several months for you to receive a statement with the current contribution data
