The Parker Hann f n Foundat on has recogn zed th s need and respons b ty through ts g fts to educat ona Inst tut ons To st mu ate and make more effect ve the nd v dua g fts of Parker Hann f n Corporat on ("Parker") emp oyees and d rectors (here n ca ed "emp oyees") to qua fy ng nst tut ons th s act v ty has been expanded to nc ude a program through which the Foundat on w supp ement as provided be ow qua fy ng emp oyee contributions. The conditions and imitations of the program are described here in deta

The Program

Subject to the fo owng terms and cond tons effect ve on or after Juy 1 2016 the Foundat on agrees that tw match one-forone any amounts contributed to any accred ted educational nstitution in each fiscal year by an engineer given by each group of Parker provided that any single gift by such person shall not be essithan \$100 the total amounts matched by the Foundat on in any fiscal year for an employees contributions to any single institution shall not exceed \$5,000 and the total amounts matched by the Foundation for all of an employees contributions to a accredited educational institutions in each fiscal year shall not exceed \$10,000

Employee Eligibility

An e gbe empoyee s:

- A An act ve fu -t me hour y or sa ar ed emp oyee (not c ass f ed as temporary or part-t me) or a ret ree of Parker who comp eted at east one year of cont nuous serv ce w th Parker or a who y-owned Un ted States subs d ary; or
- B A member of the Board of D rectors of Parker

Such e g b e emp oyee may make a contr but on to more than one nst tut on The emp oyee need not have been a student at the nst tut on

Qualifying Institutions

The schoo must be ocated within the United States and qualify as one of the following:

- A private or pubic elementary or secondary school college or university accredited by a regional or professional accrediting association; or
- B A reg ona y accred ted two- year jun or co ege whose cred ts are transferab e to a reg ona y accred ted four-year degree grant ng co ege or un vers ty for cred t towards a bache or s degree

Each such schoo must be an educat ona nst tut on contr but ons to which are deduct bie for Federa income tax purposes and with respect to which the United States Treasury Department has ssued a ruing to such effect which ruing is in full force and effect at the time when a contribution is made to it by the Foundation

A Contr but on to a corporat on fund or foundat on which has as its objective the collection and appication of funds exclusively for the benefit of one or more such colleges universities elementary schools or secondary schools shall be considered as a contribution to a qualified educational institution.

Employee Contributions

To be considered qualified the employee's contribution must be:

- A The persona g ft of an e g b e Parker emp oyee;
- B Made n cash or securtes having a quoted market value; and
- C Actua y pa d and not mere y p edged to a qua f ed educat ona nst tut on

An e g b e emp oyee may make contr but ons to more than one qua f ed educat ona nst tut on No prov s ons w be made for contr but ons through payro deduct ons

Parker Hannifin Foundation's Contribution

The tota of a Foundat on contr but ons under this program sha not exceed the amount a located each fiscal year for this purpose by the Trustees of the Foundation. Matching gifts will be made in order of date of receipt of the acknowledgment from the recipient school until the end of the fiscal year or until the allocated funds are depicted, whichever significantly support to the program of the fiscal year or until the allocated funds are depicted.

Administration

This program shall be administered by the Trustees of the Foundation and any questions as to interpretation application or administration of the provisions of the Program or otherwise shall be determined by the Trustees whose decisions shall be final. The Foundation retains the right to amend revise suspend or terminate this Program at any time with respect to employee contributions made thereafter.

Operation

- C Upon recept of the completed Application the Trustees will:
 - Determ ne the e g b ty of the Parker emp oyee and the qua f cat on of the educat ona nst tut on n accordance w th the prov s ons of the Program;
 - 2 Forward to each qua f ed educat ona nst tut on as soon as poss b e dur ng the current f sca year as may be determ ned by the Trustees a check cover ng a contr but ons to which such institution shall be entitled under the provisions of the Program; and
